Recall #: CANR09 | R09 - Remedy Notice - Certain 2009-2012 model year RAV4 vehicles - Wiper Motor Link Corrosion (Ph2 Remedy)

Recall Description

In the involved vehicles, water dripping onto the windshield wiper motor link can, over time, cause corrosion and wear at the wiper link joint. In some cases, this could result in the separation of the wiper link from the wiper motor crank arm. If separation occurs, the windshield wipers could become inoperative, which could reduce driver visibility and increase the risk of a vehicle crash.

Remedy

Toyota will provide a two-phase remedy at no cost to you. Due to parts availability, each phase will be released at different times.1) Replacement of the front wiper crank arm sub-assembly with an improved part. (March 2016)2) Replacement of the cowl louver with an improved part. (TBD)

On certain vehicles, in the event of a severe frontal collision, there is a possibility that the webbing of the seat belt in both second-row outboard seating positions could contact a portion of the metal seat cushion frame, become cut, and separate.

Remedy

Dealers will install plastic protectors on the seat cushion frame in both second-row outboard seating positions.
